(a) Planning Reports

<u>Parish Council Application for Tree work in the Recreation Ground.</u>
The documentation giving approval of the Application had been sent by GBC to the tree surgeon – not to the parish clerk.

Mary brought the council up-to-date with current planning applications: 06/P/ 02072 application for a new stable block at Old Manor Farm. Permission refused.

New applications:

06/P/02298. Application for new gateway at Home Farm Buildings.

<u>06/P/02320</u> Application for new stable block at Hilltop Farm. Three members of the parish council have visited the site and met with the owner. The views of the parish council have been sent to GBC.

(b) Planning Enforcement

<u>O6/P/01698</u> development at <u>Doverhay</u>. (The owners of Doverhay were present and explained the situation to the parish council.)

Following concern expressed by a member of the public that these developments are not all in accordance with the Planning permission granted, an Enforcement Officer from GBC has visited the site; the matter is now being satisfactorily resolved.

<u>Clandon Manor Farm.</u> Mary was asked to contact the owner/developer (Mark Savage) to find out his future plans for the site, in view of the dismissal of his appeal.

12/12/06 Page 3 a. <u>fencing/gate</u>. With reference to the briefing paper, Phase 2 of the Improvement Plan was approved: renewal of the fencing to the field, and improvement to the entrance way with purchase of a new gate. Following

discussion about the style of fencing, it was decided that rustic fencing with morticed joints, and sheep netting would be most suitable although expensive. The quote from Juniper was accepted in principle.(the company has worked elsewhere in the village). The councillors will inspect carefully the area which needs new fencing.

b. <u>Lease renewal</u>. Matthew Pitt has indicated that he would like to renew the lease for a further year. However, it was decided that renewal for a 6 month period would be advisable, while the council decides on future letting arrangements of the field. It is the council's major source of income, and with the pasture improvements already nearly completed, the field is attractive to more potential lesees. It may be advisable to divide the field into 3 separate grazing areas in order to maximise usage of the field and income. An email will be sent around the village to find out if there are other people interested in a lease. This would therefore increase its use as well as increase of income to ECPC. Roger will discuss this with Matt before any decisions are taken, and report back to the council.
