- b. <u>Concurrent Functions Grant Aid for 2012/13</u>. This will be discussed at the meeting on 11th September, and GBC informed of the decision.

- d. <u>Policy Decisions for small sums of money</u>. Mary was asked to look through meeting Minutes of a few years ago to remind the council of any decisions made regarding the spending of small sums of money without the need to refer to full council, or to obtain three estimates before any work can be carried out.
