13/006 Village Traffic Issues

a. along the Ripley Road

Mary informed the councillors that she has received a reply from SCC Highways Department. They have inspected the road and informed us that "there are no outstanding defects at intervention level". Councillors were not happy with this reply, and asked Mary to follow it up with another letter, asking for an on-site meeting between SCC Highways and village representatives. b. <u>Blind corner approach to the village from A246</u>. It was reluctantly concluded that, due to the narrowness of this corner, that nothing more can be done to ensure the safety of pedestrians except to keep the vegetation well trimmed. It was noted that a safer pedestrian approach to the centre of the village from the A246 is via The Old Epsom Road and then walking along the footway which connects with St Thomas Drive.

13/007 Surrey Hills AONB Boundary review.

An update on the status has been provided by the CPRE regarding the proposal to incorporate all the AGLV on the south side of the A246 into the AONB. Further that the work on the boundary review, supported by all the local parish councils, is planned to take place during the early part of 2013 and that the funding will come from Natural England 50% and districts across Surrey providing the other 50%.
